A man sought by Baileyton police in connection with a vehicle pursuit last week was taken into custody Saturday by sheriff's deputies after the suspect's car was seen parked at a house in the 3000 block of Gap Creek Road in Mosheim.

Danny Ray Cutshall, 35, of 3500

Gap Creek Road, was sought on arrest warrants for felony counts of evading arrest and reckless endangerment, along with a theft of property/shoplifting charge.

A blue car matching the description of one "used the week prior to flee from officers" in Baileyton was parked at the address, Deputy Michael Ball said in a report. Cutshall was identified as the alleged driver.

Cutshall was found in the house and taken into custody pending a first scheduled appearance today in General Sessions Court.

A deputy found the van running and the suspect, later identified as Timothy Tullock. 32, 239 Robert Harmon Road, slumped over in the driver's seat. The officer turned the van off, took the keys out and snapped several photos of the suspect. Once Tullock was awake he allegedly told deputies he pulled in the driveway at 2 or 3 a.m. and had "taken downers."

Tullock was described as having bloodshot eyes and slurred speech. He was charged with public intoxication. During a search, the officer allegedly found white and blue pills and a bag of meth on his person. A search of the vehicle allegedly turned up a syringe, marijuana and rolling papers. Also inside the vehicle were another syringe, empty blue plastic baggie and a clear plastic baggie allegedly containing meth. Tullock was additionally charged with possession of schedule II drugs, possession of schedule VI drugs, possession of meth, possession of a legend drug and possession of drug paraphernalia. His first scheduled court appearance was set for Monday.


